Sanli Secures New Contracts Across Private and Public Sectors with an Aggregate Value of Approximately S\$60.1 Million

- The majority of the new contract wins originated from the public sector, including approximately S\$57.7 million awarded by the Group's major customer under contracts with varying service tenures, reflecting the Group's strong and long-standing customer relationships.
- Following a strong year of EPC project wins in 2025 that boosted its order book to a record level, the Group continues to prioritise on the timely execution and delivery of projects execution of these EPC projects for its private clients and public sector customers (such as PUB and LTA).

SINGAPORE, 27 July 2026 – SGX-Catalist listed Sanli Environmental Limited (“**Sanli**”, the “**Company**”, “三立环境有限公司” and together with its subsidiaries, the “**Group**”), would like to provide key business updates on its recent contract wins with an aggregate value of approximately S\$60.1 million, which includes S\$33.0 million of new contracts secured during the three-month period from 1 April to 30 June 2026, followed by an additional S\$27.1 million of contracts secured in July 2026.

These new contracts span both the public and private sectors, encompassing engineering works, system upgrades, and maintenance services in the water and environmental infrastructure sector within Singapore and Malaysia.

Mr. Sim Hock Heng (“沈福兴”), Chief Executive Officer and Executive Director of Sanli, said: “While these contracts may be individually smaller in value, collectively they represent a resilient stream of business that reflects the strength of our long-standing customer relationships, which we have built over 20 years through consistent project delivery and operational excellence.

As Singapore continues to invest in water infrastructure to support urban development and the growing demand from mission-critical sectors such as data centres, we believe the Group is well-positioned to harness further opportunities in this essential sector.”
