Sanli secures S\$10.0 million worth of new contracts

- Order book stands at S\$114.3 million
- Contracts to contribute to revenue from FY2018

SINGAPORE, 10 January 2018 – Sanli Environmental Limited (“Sanli” and together with its subsidiaries, the “Group”), a Singapore-based environmental engineering company has announced that it has secured three new contracts (the “Contracts”) worth a total of S\$10.0 million, bringing the Group’s order book to S\$114.3 million. These contracts are from both the private and public sectors.

The Contracts comprise projects in both Engineering, Procurement and Construction (“EPC”) and Operations and Maintenance segments. The EPC contract involves the design, engineering, manufacturing, testing, delivery and erection & commissioning of a pilot plant for water treatment. Under the Operations and Maintenance contracts, Sanli will be involved in the servicing and maintenance of screening, sludge, grit and related equipment at various water reclamation plants, as well as the maintenance of the existing volatile organic compound (VOC) remote monitoring system.

Mr Sim Hock Heng, Chief Executive Officer of Sanli said, *“The Group is greatly encouraged by the vote of confidence from our clients in both the public and private sectors. This affirms the quality of our services in the water and waste management sector. We will continue to tap on the demand for water and waste management solutions to grow the business further.”*

The Contracts are expected to contribute to the Group’s revenue for the financial year ending 31 March 2018.
